Also, in my own behalf or on behalf of the Minor, hereby assign, transfer and forever grant The Dance Place Ltd. the right to photograph and/or videotape the said student as a part of our annual recitals and/or promotions.

TUITION SCHEDULE AND ENROLLMENT

I am not obligated by contract to continue dance study, however, I understand I am enrolling in a 10 month dance season, that has reoccurring monthly tuition and I am continuously enrolled in the program and I will incur reoccurring monthly tuition charges on my account until I submit a written **drop request** to The Dance Place Ltd reception desk. This document may be obtained from the Dance Place front desk or downloaded from our website www.danceplaceltd.com. If I am dropping a class (with reoccurring monthly tuition) it must be done on or before the last day of the month. If I drop a class after the month begins I will not receive credits and/or refunds for the remaining classes in the current month. I understand that The Dance Place Ltd. **does** provide make-up classes for dance-season classes, and does not give credit and/or refunds for, but not limited to programs, class(es), sessions, camp or costumes. I am responsible to make timely payments of my balances due on my Dance Place account. From the date of registration forward, my monthly tuition balance shall be due the 1st of each month. The total cost of the dance season is divided into 10 equal monthly tuition payments, regardless of holiday breaks in any particular month. Costume payments will be made by whatever method of payment I choose, by the advertised due date. If my Tuition or Costume payment is not received on or before the due date, The Dance Place Ltd. will initiate a **late fee of \$15.00**.

BILLING INFORMATION

Payments will be processed with the payment method I have chosen, on the **registration form** that is kept on-file with The Dance Place Ltd. If provided, an e-mail notification will be sent any time a payment is processed. I acknowledge that this authorization will remain in effect until I notify the Dance Place front desk, in writing, that the authorization should be terminated. If for whatever reason, payments cannot be processed and my account balance remains overdue, I understand that my enrollment in classes will be cancelled. I will be responsible for all costs incurred for collection of any delinquent payments, including but not limited to: collection/ attorney fees/ court costs. I understand that monthly payment amounts may vary as classes are added or dropped and as other charges/payments are applied to my account. I understand **a \$25.00 fee will be charged to my account for insufficient funds, expired/declined credit cards and EFT returns**, for all un-paid accounts monthly. New and updated billing, address and telephone information is the responsibility of the member, and not the responsibility of Dance Place to notify the member of expired/declined credit cards and EFT returns. All overdue accounts/late payments will incur a \$15 late fee. There is no grace period, Tuition is predictable, due the 1st of every month & credit cards are accepted.
